Grand Council - Sante' Mawio'mi

Prior to the arrival of Europeans, the Mi'kmaw Nation was a self-governing Nation whereby important decisions were contemplated through the body of the traditional Mi'kmaw government - the Mi'kmaw Grand Council. This structure found its basis at the village level, whereby a local chief presided over the council of Elders of his village or band and was responsible to carry out the decisions of his group of elders. Although local chiefs did not hold an official position within the

Sante' Mawio'mi, their concerns were brought forth by the District Chiefs. The district chief presided over his area's council of local chiefs, with the responsibility of settling issues that might cause serious conflict among the districts, or between Nations such as Treaty signing or alliances or in time of war. The Sante' Mawio'mi was comprised of representatives from each of the seven Nikanus (District Chief), Kji-Keptin (Grand Captain), the Putu's (Recorder/Secretary) and the Grand Council Leader, the Kji-Saqmaw (Grand Chief). All discussions within the council were based on consensus and included mutual respect and trust as a code of governance.

Today, the Sante' Mawio'mi plays a significant and critical role in the Mi'kmaw Nation, ensuring that our culture and language is maintained, preserved, and encouraged.

- Kwilmu'kw Maw-klusuaqn is also known as Mi'kmaq Rights Initiative. Kwilmu'kw Maw-klusuaqn means 'we are seeking consensus.' The Mi'kmaq Rights Initiative is seeking consensus on the best ways to implement our Aboriginal and treaty rights... for now, and for seven generations to come.
- The Mi'kmaq Rights Initiative is the group that represents the negotiations on behalf of the Mi'kmaq of Nova Scotia with the Province of Nova Scotia and the Government of Canada.
- The five pillars of the Mi'kmag Rights Initiative for the Mi'kmag are:
 - [1] To achieve recognition, acceptance, implementation and protection of treaty, title, and other rights of the Mi'kmaq in Nova Scotia;
 - [2] To develop systems of Mi'kmaq governance and resource management;
 - [3] To revive, promote and protect a healthy Mi'kmag identity;
 - [4] To obtain the basis for a shared economy and social development; and,
 - [5] To negotiate toward these goals with community involvement and support.
- Part of the KMK process involves tri-partite negotiations over Mi'kmaq rights and title between the Mi'kmaq, Nova Scotia and Canada. The negotiators seeks to act with the concurrence of all 13 Chiefs. The Chiefs, in turn, will make sure they have the support of their Councils and communities.
- In light of SCC decisions regarding the duty to consult and accommodate with regard to
 proven and asserted Aboriginal and Treaty rights, the Assembly has signed a Terms of
 Reference with respect to consultation by government and has an office within the KMKNO
 to address consultation and accommodation. With over 100 consultations currently
 underway many of Nova Scotia's most prominent corporations have become engaged in
 the consultation process.

• The Mi'kmaq Legal Support Network (MLSN) exists as a justice support system for Aboriginal people who are involved in the criminal justice system in Nova Scotia. Through the past number of years, MLSN has provided core services through the Mi'kmaq Court Worker and Mi'kmaq Customary Law Programs. Both programs are administered through a centralized umbrella organization hosted at The Confederacy of Mainland Mi'kmaq. This umbrella or core provides additional support services for Aboriginal people in Nova Scotia by identifying and addressing gaps in the provision of mainstream justice programs and services. Since its inception, MLSN has always attempted to make a non-Mi'kmaq system of justice better for Aboriginal people in Nova Scotia. This system is largely process oriented and lacking Aboriginal cultural values. MLSN programs and services help bridge these gaps but is often found that the criminal justice system needs to be more receptive to Mi'kmaq concepts of justice.
